In the event I breach this contract by refusing or failing, without just cause, to connect to the system or pay the minimum monthly rate, I understand that I forfeit my initial connection fee. Should I desire services at some later time, I understand that I must pay the connection in effect at that time. I further understand that unpaid bills shall constitute a lien upon my real estate and legal action can be pursued to collect the delinquent charges.

The meter shall be placed on a mutually agreed upon location on the Members property. The Member shall be responsible for installation and maintenance of service lines between the meter and the residence or business. The Member shall be responsible for making the connection to the meter. The Member shall be responsible for the proof of ownership or recorded easement (if meter is set on property not belonging to Member). If the meter location provided by the Member is found to be outside these limits, the Member shall be responsible for all costs related to relocating the meter.
